**Subject:- Grant of Conditional Permission to HKDET's Rajarajeshwari Ayurvedic Medical College & Hospital, Near Sindenker Cross, Veerabhadragiri, NH-65, Humnabad, Dist- Bidar -585330, Karnataka (AYU0480) with 60 seats in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24 and issuance of Letter of Permission for increase in intake capacity in existing UG BAMS course from 60 seats to 100 seats and to start 04 new PG Courses with 24 seats, in the subjects namely (i) Kayachikitsa-06 seats, (ii) Samhita Siddhanta-06 seats, (iii) Shalya tantra-06 seats & (iv) Prasuti Tantra & Striroga - 06 seats, from the academic session 2023-24 under section 29 of NCISM Act, 2020 and relevant regulations thereunder- reg.**

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

1. I am to refer to your application vide ref.no. HKDET/RRAMCH/intake-2/22 and HKDET/RRAMCH/PG-1/22 dated 29/11/2022, on the subject cited above and to verify the available facilities of teaching, non-teaching, hospital staff and other facilities available at your college namely **HKDET's Rajarajeshwari Ayurvedic Medical College & Hospital, Near Sindenker Cross, Veerabhadragiri, NH-65, Humnabad, Dist- Bidar -585330, Karnataka (AYU0480) for increase in intake capacity in existing UG BAMS course from 60 seats to 100 seats and to start 04 new PG Courses with 24 seats, in the subjects namely (i) Kayachikitsa-06 seats, (ii) Samhita Siddhanta-06 seats, (iii) Shalya tantra-06 seats & (iv) Prasuti Tantra & Striroga - 06 seats**, visitation has been carried out for issuance of Letter of Intent (LOI) on **08.06.2023 & 09.06.2023 through hybrid mode** by the visitation team of Medical Assessment and Rating Board (NCISM) and Letter of Intent (LOI) has been issued to your college vide letter of **even no. dated 16.08.2023 for increase in intake capacity in existing UG BAMS course from 60 seats to 100 seats and to start 04 new PG Courses with 24 seats, in the subjects namely (i) Kayachikitsa-06 seats, (ii) Samhita Siddhanta-06 seats, (iii) Shalya tantra-06 seats & (iv) Prasuti Tantra & Striroga - 06 seats, from the academic session 2023-24.**
2. The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out an inspection of the college again on **21.09.2023 and 22.09.2023 through Hybrid mode** to assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities available **for issuance of conditional permission for intake capacity with 60 seats in UG (BAMS) Course under section 28 of NCISM Act, 2020 for the academic session 2023-24 and for issuance of Letter of Permission for increase in intake capacity in existing UG BAMS course from 60 seats to 100 seats and to start 04 new PG Courses with 24 seats, in the subjects namely (i) Kayachikitsa-06 seats, (ii) Samhita Siddhanta-06 seats, (iii) Shalya tantra-06 seats & (iv) Prasuti Tantra & Striroga - 06 seats, from the academic session 2023-24 under section 29 of NCISM Act 2020.**
3. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", and all the requirements of the Indian Medicine Central

4. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the **62<sup>nd</sup> Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held **on 04.10.2023**. On careful examination of the assessment report it was found that there were certain shortcomings in your college. **Hence, the Board decided to ask the clarification regarding the shortcomings found during the assessment and same was communicated to you vide letter of even no. dated 04.10.2023**. In response on the same, you have submitted the clarification vide letter ref. no. HKDET/RRAMC/C-126/2023 dated 04.10.2023. After analyzing the clarification it has been decided to **issue the Conditional Permission with 60 seats in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24 and to issue Letter of Permission for increase in intake capacity in existing UG BAMS course from 60 seats to 100 seats and to start 04 new PG Courses with 24 seats, in the subjects namely (i) Kayachikitsa-06 seats, (ii) Samhita Siddhanta-06 seats, (iii) Shalya tantra-06 seats & (iv) Prasuti Tantra & Stri roga - 06 seats, from the academic session 2023-24 under section 29 of NCISM Act 2020.**
5. Further, in accordance of the regulation **6 (2) (i) (i) and 6 (3) (j) (ii)** of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, a letter of even no. **dated 05.10.2023** was sent to the college to furnish fixed security deposit worth **Rupees 2 crore 50 lakhs with Rs. 2 crore (50 Lakhs Per PG Subject)** as fixed security deposit for a period of three years to start 04 new **PG Courses with 24 seats, in the subjects namely (i) Kayachikitsa-06 seats, (ii) Samhita Siddhanta-06 seats, (iii) Shalya tantra-06 seats & (iv) Prasuti Tantra & Stri roga - 06 seats, and Rs. 50 Lakhs (Fifty Lakhs)** as fixed security deposit for a period of five years for **increase intake capacity in existing UG (BAMS) course from 60 to 100 seats** from the academic session 2023-24 in favor of National Commission fund for Indian system of Medicine. **In response of the same, the college has furnished the fixed security deposit of rupees 2 crore 50 lakhs in favor of the National Commission fund for Indian system of Medicine through RTGS account No. 11092100005585 transferred by Karnataka Gramin Bank, Humnabad, dated 05.10.2023 (for a period of five years) and informed the same vide an email dated enclosing a letter vide ref. no. HKDET/RRAMC/Fee-2/23 dated 05.10.2023.**
6. Therefore, **Conditional Permission is issued to, HKDET's Rajarajeshwari Ayurvedic Medical College & Hospital, Near Sindenkera Cross, Veerabhadragiri, NH-65, Humnabad, Dist- Bidar -585330, Karnataka (AYU0480) with 60 seats in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24 and Letter of Permission is issued for increase in intake capacity in existing UG BAMS course from 60 seats to 100 seats and to start 04 new PG Courses with 24 seats, in the subjects namely (i) Kayachikitsa-06 seats, (ii) Samhita Siddhanta-06 seats, (iii) Shalya tantra-06 seats & (iv) Prasuti Tantra & Stri roga - 06 seats from the academic session 2023-24 under section 29 of NCISM Act, 2020 and relevant regulations thereunder** subject to the condition that college is fulfilling the following requirements: -
  - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the colleges/hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant rules and regulations.
  - II. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity **with 100 seats in UG and** minimum 15% of postgraduate seats of the permitted intake capacity **with 24 Seats in 04 PG courses** shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for All India Quota or the students admitted thereunder.**
  - III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
7. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
8. Further, **as per Sub-section (7) of Section 29 of NCISM Act, 2020**, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then **in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular or the subsequent academic year**
9. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.

10. **The following requirements should be fulfilled by the college by 31<sup>st</sup> December, 2023 and send a compliance report to get permission for the academic session 2024-25: -**
- All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda).
  - All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto; and
  - All the requirements of the Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, 2016.
11. This permission **for increase in intake capacity in existing UG (BAMS) course from 60 seats to 100 seats and to start 04 new PG courses with 24 seats from the academic session 2023-24** as stated above for the first admitted batch of 2023-24 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 35 of the NCISM Act 2020.
12. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.
